## PETITION.

*To the Honourable the Speaker and Members of the Legislative Assembly of the Province of British Columbia:*

The petition of the undersigned sheweth:—

That a petition has been presented to the House by The West Kootenay Power and Light Company, Limited, praying for an amendment to their original Act of incorporation, so as to allow the said Company to supply power to those requiring the same in the County of Yale.

There is at the site of the works of The West Kootenay Power and Light Company, Limited, at Bonnington Falls, in the District of Kootenay, a large available water power, and the said Company are at the present time engaged in developing the same on a very large scale.

The production of the mines in the District of Yale, and particularly in and near to the Cities of Phoenix and Greenwood, has been enormously increased in the years 1904 and 1905.

Increased power for the successful carrying on of mining and smelting operations in the County of Yale is much needed and is in the public interest.

There is no available water power in the southern portion of the District of Yale which can supply the present and future needs of the mines and smelters now existing in and in the vicinity of the said Cities of Greenwood, Phoenix and Grand Forks.

Wherefore your petitioners humbly pray that the powers asked for by The West Kootenay Power and Light Company, Limited, in their petition be granted.
