Explanatory Note for Table of Concordance Pre-RS2024 to RS2024

This Table of Concordance was compiled during the revision drafting process and the resulting data were used to prepare the Table as an unofficial guide for users of B.C. Statutes. While every effort was made to achieve accuracy, only the statutes are authoritative. Legal opinion should be sought if interpretation is required.

This Table was based on the table of contents for the pre-RS2024 Act, as that Act read at the time the revision was delivered for consideration by Select Standing Committee of the Legislative Assembly. The left columns indicate the provision of the pre-RS2024 Act that is the source for the RS2024 Act provision indicated in the right column of the same row.

If a pre-RS2024 section was revised into more than one RS2024 section, the left columns will indicate this separation with “[pt]”. If provisions were revised into the Schedule to the RS2024 Act, the right columns will indicate this with “(Sched)”.

See the “Table of Concordance RS2024 to Pre-RS2024” to this Act to identify a specific revised section in the RS2024 Act with its source section in the pre-RS2024 Act.
