In accordance with 1.14.11 of the Maa-nulth First Nations Final Agreement (the "Final Agreement") notice is hereby provided that in accordance with 2.10.1 through 2.10.6 of the Final Agreement, Ucluelet First Nation has requested that Canada and British Columbia consent to lands being added to the Maa-nulth First Nation Lands of Ucluelet First Nation and Canada consented on August 20, 2013 and British Columbia consented on October 11, 2013. The lands added are legally described as Block B, District Lot 462, Clayoquot District and Block C, District Lot 483, Clayoquot District and are owned by the Ucluelet First Nation. Further, in accordance with 2.10.6 of the Final Agreement, Appendix B-5, Part 2(a) Plan 1 is deemed to be amended to reflect the addition of these lands, as shown on the attached schedule.

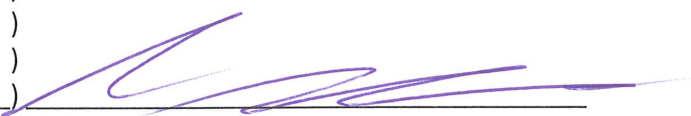
