**NORTH ISLAND-COAST DEVELOPMENT INITIATIVE
TRUST REGIONS REGULATION**

B.C. Reg. 34/2006

Definitions

1 In this regulation:

“**Act**” means the *North Island-Coast Development Initiative Trust Act*;

“**electoral area**” has the same meaning as in the *Local Government Act*.

Regions defined

2 For the purposes of the Act:

“**Central South Island region**” means that area of British Columbia comprising the following:

- (a) in the Powell River Regional District, electoral area E;
- (b) in the Regional District of Nanaimo, electoral areas A, B, C and E, the City of Nanaimo, the City of Parksville and the District of Lantzville;
- (c) the Cowichan Valley Regional District;
- (d) in the Capital Regional District, the Juan de Fuca Electoral Area, the Saltspring Island Electoral Area and the Southern Gulf Islands Electoral Area;

“**North Island-Sunshine Coast region**” means that area of British Columbia comprising the following:

- (a) the Regional District of Mount Waddington;
- (b) the Regional District of Comox-Strathcona;
- (c) the Regional District of Alberni-Clayoquot;
- (d) in the Regional District of Nanaimo, electoral areas F, G and H, and the Town of Qualicum Beach;
- (e) the Powell River Regional District, except electoral area E;
- (f) the Sunshine Coast Regional District.
