Prayers by Brig. R. Thierstein.

Mr. Speaker addressed the House as follows:--

Honourable Members,—During the course of the current Session I have felt that members have, on several occasions, used words and phrases that are not only in bad taste from the point of view of the dignity of the House but, in many instances, those words and phrases have been expressly unparliamentary.

The use of the words "deceit," "massive deception," the use of the word "liar" as applied to an honourable member, the use of the word "lie" as applied to an honourable member's statement, and the use of the word "dirty" as applied to another member or his speech are all to be deplored, and I will ask the honourable members to avoid such speech either in the course of the debate or hurled across the floor while another member is speaking.

I might say that there is ample precedent in the Commonwealth Parliaments wherein the above words and phrases have been held to be unparliamentary, but quite apart from precedent I would suggest that the honourable members should strive to avoid any language which would impair the dignity of our proceedings.

I would also like to say that no member will be permitted to quote the words of another if those words quoted would be considered unparliamentary if spoken by the member in the first instance, and at the same time the members must avoid uttering words and phrases, knowing them to be unparliamentary, but prepared to immediately withdraw them upon being called to task by the Chair.
