Resolution and Bill reported.

Report adopted.

Bill introduced and read a first time.

By leave of the House, the Hon. Mr. MacDonald moved, "That the Bill be now read a second time."

A debate arose.

The House continued to sit after midnight.

FRIDAY, NOVEMBER 20TH.

Bill read a second time, and Ordered to be committed at the next sitting.

Mr. D. McPherson presented the First Report of the Select Standing Committee on Mining, as follows:-

REPORT No. 1.

LEGISLATIVE COMMITTEE ROOM,

November 19th, 1936.

MR. SPEAKER:

Your Select Standing Committee on Mining begs leave to report as follows:-

- 1. We note with satisfaction the attitude taken by the Dominion Minister of Mines with respect to the importance of the mining industry, and desire to voice our appreciation of the financial assistance rendered to this Province in connection therewith.
- 2. We commend the Government for its progressive attitude towards the mining industry, as evidenced by Bills brought down at this Session to amend the "Metalliferous Mines

Regulation Act," the "Ore Treatment and Purchasing Act," and the "Workmen's Compensation Act" as affecting mine-workers afflicted with silicosis.

- 3. We recommend the establishment by the Government of small sampling plants at suitable locations, with a view to assisting the prospector and small mine operator who are denied the advantages of accurate information regarding their properties by the diminutive character of their operations and the high cost of transportation to existing smelters.
- 4. We urge the Government to consider the setting-up of Young Men's Training Camps in connection with the mining industry, patterned somewhat after the fashion of the camps which have been so successful in the Forest Service.
- 5. We believe that the Department of Mines should be provided with funds sufficient to permit the development of more adequate transportation facilities, by air and otherwise, in the more remote areas of the Province; to facilitate the assembling and distribution of useful geological information; and to dispel by vigorous publicity the prevailing ignorance of this Province's mining possibilities existing in Eastern Canada.
- 6. We respectfully request that the Government take steps to correct at the next Session of the Legislature the existing situation with respect to the status of reverted mineral claims, the encumbrance thereof with many years' tax accumulation, and other circumstances which tend to discourage mineral production. The co-operation of the Department of Finance, affecting taxation, is necessary in this connection, and we beg to remind the Government that this Committee made practical suggestions on this subject two years ago.
- 7. This Committee has learned with much regret of the serious illness of Mr. Robert Dunn, Deputy Minister of Mines, and desires to express its appreciation of his valuable services to the mining industry during the past number of years. We sincerely hope that he may soon be restored to health.

- "2 and 3. Negotiations not complete; this information will be made available to the Public Accounts Committee in due course."

Mr. Uphill asked the Hon. the Minister of Public Works the following questions:—

- 1. Was the firm of Fred Mannix & Company, of Calgary, Alberta, awarded a contract on the road between Golden and Windermere; and, if so, when?
 - 2. What sum of money is being expended on this work?

 - 5. Is this firm of contractors purchasing their supplies from local firms in the district?

REPORT No. 1.

LEGISLATIVE COMMITTEE ROOM, November 20th, 1936.

MR. SPEAKER:

Your Select Standing Committee on Agriculture, instructed by Resolution of the Legislative Assembly dated November 9th, 1936, to make an investigation into the operation of the B.C. Coast Vegetable Marketing Board and its Agency, and in particular any alleged partiality or uneconomic administration in the handling of the produce grown within the areas under its jurisdiction, duly proceeded to investigate the above matters and received all evidence tendered.

It required ten sittings of your Committee to examine thirty-three witnesses and to receive all other relevant evidence.

The evidence submitted did not disclose partiality or uneconomic administration on the part of the Board or its Agency.

The evidence disclosed considerable dissatisfaction and misunderstanding among growers due to insufficient information. Your Committee suggest that, in addition to the present methods of supplying information to producers, the Board might usefully employ the radio and press for that purpose.

The evidence disclosed a considerable spread between the grower and the consumer. Your Committee feel that the question of the necessity or otherwise for this spread can only be determined by a commission having wider powers than your Committee.

Your Committee are of the opinion that a greater volume of produce marketed through the Board would reduce the costs of administration and consequently the cost to the individual producer. The unlawful marketing of produce otherwise than through the Board has tended considerably to reduce the volume handled by the Board.

Your Committee were satisfied from the evidence adduced that the Board are making every reasonable effort to curtail this unlawful marketing of produce.

Several growers appearing as witnesses, speaking for themselves and purporting to represent a considerable body of opinion among the growers, expressed the opinion that there should be an independent audit of the Agency's books.

As stated above, the evidence adduced did not disclose any irregularities in the operations of the Board or its Agency. Nevertheless, your Committee feel that such an audit would have a good effect and might tend to eliminate a great deal of the dissatisfaction which now exists.

- (No. 80) An Act to amend the "Municipal Act."
- (No. 81) An Act to amend the "Natural Products Marketing (British Columbia) Act."

His Honour was pleased, in His Majesty's name, to give assent to the said Bills.

The said assent was announced by the Clerk of the House in the following words:-

"In His Majesty's name, His Honour the Lieutenant-Governor doth assent to these Bills."

Then Mr. Speaker addressed His Honour the Lieutenant-Governor as follows:— May it please Your Honour:

We, His Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to His Majesty's person and Government and humbly beg to present for Your Honour's acceptance Bill (No. 60) intituled "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In His Majesty's name, His Honour the Lieutenant-Governor doth thank His Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

I desire to express appreciation of the earnestness of purpose which has characterized your deliberations. I feel sure that the measures which have been enacted will inure to the welfare of the people of the Province.

The position of the municipalities will be greatly improved through the assumption by the Province of the entire cost of numerous social services.

It is noteworthy that the financial position of the Province has been greatly improved and that the assistance to be given to the municipalities will not entail any increase in taxation.

More effective measures are being adopted in connection with the unemployment problem and practical proposals are being effectuated in conjunction with the Dominion Government to provide work of essentially useful character.

The establishment of ore-purchasing plants will much encourage prospecting and development in our mining industry.

Provision for capital expenditure upon necessary and desirable public undertakings will be of great benefit to the public service, as well as furnishing employment for large numbers of our people.

It is to be hoped that legislation in respect of the important problem of the marketing of our natural products may effectually accomplish its purpose and thereby be beneficial alike to the industries concerned and to the public generally.

The provision to facilitate refunding of municipal obligations upon a basis of agreement between the municipalities and the bondholders, with proper safeguards, should be mutually advantageous.

In relieving you of your labours, I pray that the blessing of Divine Providence may accompany you to your respective homes.

The Hon. Mr. Weir, Provincial Secretary, then said: Mr. Speaker and Members of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
